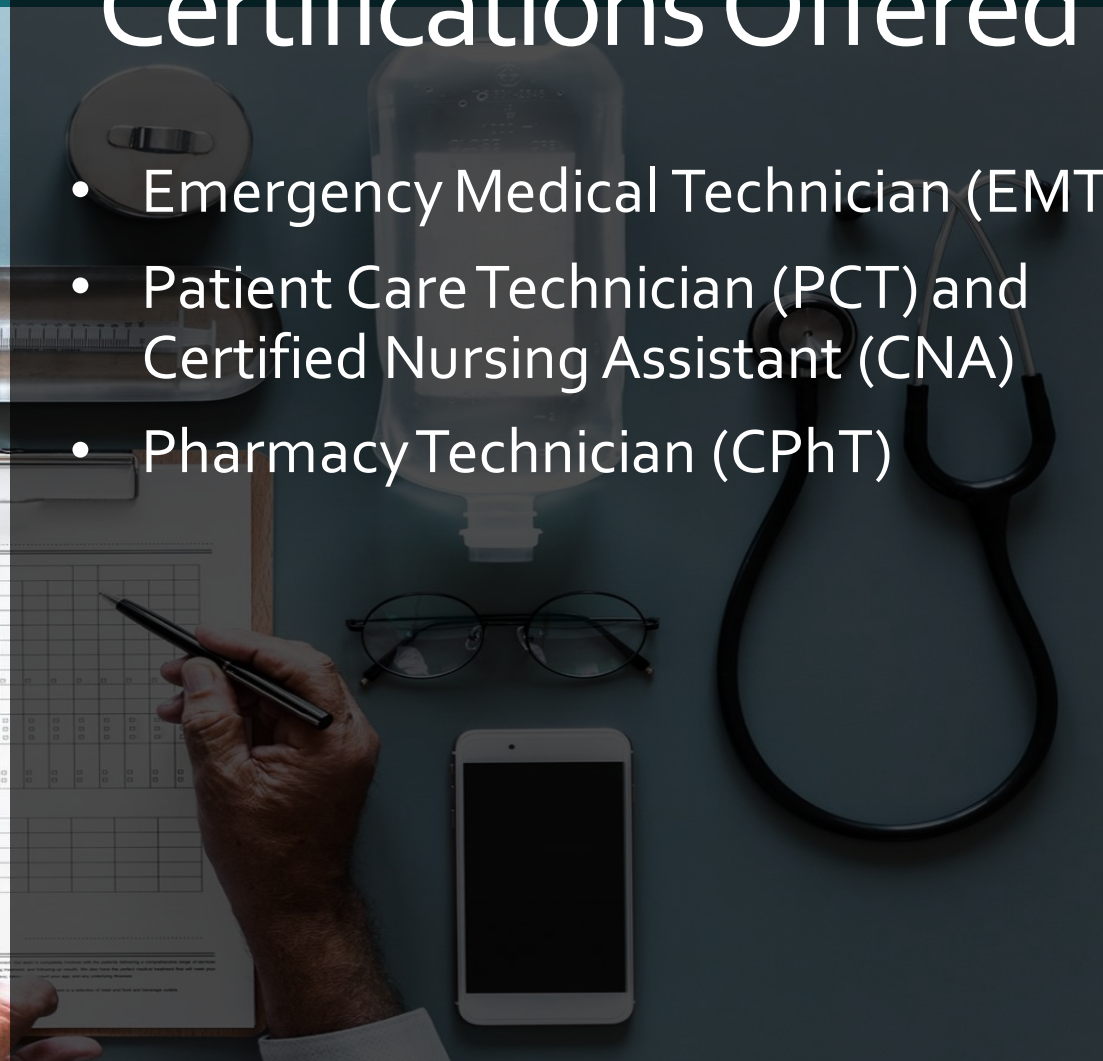

Certifications Offered

- Emergency Medical Technician (EMT)
- Patient Care Technician (PCT) and Certified Nursing Assistant (CNA)
- Pharmacy Technician (CPhT)



Emergency Medical Technician (EMT- B)

- Designed to prepare students to provide:
 - basic life support measures, as a member of an ambulance crew, at the scene of an accident, during transport to a hospital or medical facility, and within the medical facility.
- Course work combines classroom lecture, practical skills laboratory, and actual patient clinical experiences (ex: ambulance rotations).



Patient Care Technician (PCT) and Certified Nursing Assistant (CNA)

- Students learn to provide basic care for individuals in their homes or in a care facility setting.
- Patient Care Technicians work in hospitals, clinics, rehabilitation centers, long term care facilities, and physician offices.
- Professionals possess the technical skills necessary to service complex patient care issues including: rehabilitation services, diagnostic tests, basic bedside care, collection of laboratory specimens, Phlebotomy and EKG's.
- Lecture topics include: medical terminology, anatomy and physiology, miscellaneous patient care concepts, HIPAA, vital signs, patient care, personal hygiene and grooming technique among others.
- Course work combines lecture, practical skills, and actual clinical experience at a clinical site.
- Saturday clinical hours needed to complete CNA requirements.
- **Note: If you have reservations bathing, grooming, dressing wounds, and drawing blood from patients which you will perform during clinical training, this course or field may not be for you.**



Pharmacy Technician (CPhT)

- The objective of the program is to equip students with knowledge, technical skills, and work habits required for an entry-level position in the pharmacy field or related area.
- Pharmacy Technicians work under the direct supervision of a licensed pharmacist. They work in a variety of locations such as community, retail and hospital pharmacies.
- A strong emphasis is placed on ethics, accountability, professionalism, and the individual's commitment to pursue lifelong personal and professional development.
- Course work combines computer module exercises, classroom assessments, and actual pharmaceutical experiences.



Procedures for Submitting Certification Request Form

- Student/Parent (Guardian) must attend information session.
- Student will select **1 certification** on the Request Form.
- All the information on the application, including attachments and criteria requirements must be completed to be considered as a candidate for the industry certification of choice.



Industry Certification Program Criteria

- What criteria must I complete to have my application processed for industry certification?
- Students applying for enrollment must have completed the first two **Health Science** and/or **Biomedical courses** in their Health Science program of study and must currently be enrolled in their junior Health Science course.



Required Industry Documentation

- Students who are selected into an industry certification course must have the following:
 - * All immunizations, Influenza (Flu shot) and Tuberculin test up to date.
 - Immunizations
 - TB Test (updated by 1yr)
 - Flu shot
 - **Criminal Background Check
 - **Fingerprinting
 - **Drug (Urine) Test
 - ** CPR Certification

** ITEMS will be turned in at a later date.*

***All Testing noted with will be set up by BISD CTE dept.*



IMPORTANT NOTES ABOUT Health Science CERTIFICATION PROGRAMS

- **TRANSPORTATION** must BE PROVIDED BY STUDENT OR PARENT ON A DAILY BASIS
- **Certification Programs offered** at CTE Certification Center – 1905 E. 6th St.
 - CMAA/CMCB offered at Lincoln Park School – 7 Orange St.
- The course will consists of two groups:
 - Morning group: 1st and 2nd periods
 - Afternoon group: 8th and 9th periods
- Immunizations must be updated
- ALL Required documentation MUST BE SUBMITTED BY DEADLINE
 - Students may submit hard copy (handed out before spring break) or
 - Submit online form
